agreed on the following:

Article 1: Subject Matter of Agreement

Beneficiary and contractor signed this contract to determine the conditions of the logistic services during the implementation the project with number 2023-1-SK01-KA121-VET-000118049 and with name "Skúsenosť, zručnosť – cesta k úspechu" under Erasmus + Vocational Education Job Training Program.

Article 2: .Duration of the Project

This contract shall enter into force as soon as the beneficiary and the contractor have signed the contract and ends with the submission of the project final report.

Article 3: Mobilities Subject to the Contract

The dates and other information about the mobilities:

These dates can be changed with the approval of both parties. Neither party may change these dates alone.

Article 4: Responsibilities of Beneficiary

- To select the appropriate participants for the internship and prepare them for the internship with the necessary preparatory activities.
- To inform the contractor in about all the details of the project and mobility on time.
- To insure the participants and share these insurance details with the contractor.
- Pay the amount specified in the time period specified in the relevant items.

Article 5: Responsibilities of Contractor:

- To pick up from the Antalya airport and left to the hotel where they will stay at their arrival to Antalya for the internship and pick them from their hotel and left to the Antalya airport on their departure date.

Beneficiary is obliged to inform the contractor in advance of flight details. The Contractor is obliged to plan the airport transfer in such a way that it will deliver the participants on time. In case of any delay or unforeseen situation, contractor is obliged to make necessary changes to meet the participants at the airport on time. If the participants land to another airport instead of Antalya airport, the contractor will pick up the participants from this airport on condition that they are notified in time. However, Contractor has the right to charge an additional fee for another airport.

-Contractor is responsible of providing daily transportation between the participants' hotel and job training workplace. The Contractor may require participants to walk at distances of up to 1 km. If the hotel far away more than 1 km from the workplace, the Contractor is obliged to allocate the necessary means to transport the participants. The contractor can do this by public transport or by car rental. If public transport will be used for this transportation, the contractor will give the participants the relevant tickets and inform them about which public transport they will take and the schedule of these public transport vehicles.

- The Contractor will provide guidance to the participants during their stay in Turkey. A guide will be with the participants and provide information about the places and services the participants may need. The

guide will assist the participants for communication during the job training. So he/she should know English.

- The contractor will arrange the accommodation for the students in hotel including breakfast in double and triple rooms. Teachers will stay in single rooms.

- The contractor is obliged to provide 2 meals to the participants by taking into account priorities participants (not to eat pork, vegan, vegetarian etc.). The beneficiary will also inform the contractor about the eating habits of the participants one week before the mobility. Places to eat will be determined by taking into account the job training activity. In particular, it will be ensured that the lunch place is not in a place that makes it difficult to implement the job training activity. Only soft drinks are paid for student mobility. Teachers can have alcoholic drinks for dinners in preparatory visit.

-The Contractor shall arrange minimum 5 in city cultural tours according to the demand of participants at week days for job training activity. In addition, the Contractor will organize at least 1 cultural tour in Antalya province at the weekend. All costs of the tour shall be paid by the Contractor. The entrance fees for museums etc... are not under Contractor's responsibility. Contractor will organize in city cultural visits for teachers at preparatory visit too.

Article 6: Charge

. Beneficiary will pay EUR 660 Euros for preparatory visit and 5108 Euros for job training activity. The beneficiary is obliged to notify the contractor one week in advance of any changes in the number of participants. If there is less participation than expected, the beneficiary and contractor will decide on the costs according to decreasing costs of Contractor.

Madde 7: Payment

Payments will be made before each mobility.

Article 8: Bank Account
